## HISTORY

**In 2004**, Washington Area Women's Foundation embarked on a groundbreaking mission with Stepping Stones—an initiative dedicated to empowering low-income working mothers in the Washington region. Focused on fostering long-term financial independence, the Foundation aimed to create opportunities for advancement and self-reliance. A key aspect of their commitment was building a robust network of community institutions, emphasizing affordable, quality childcare as a crucial element in supporting single, low-income, women-headed households.



**In 2008**, the Foundation commissioned a study of the state of childcare and early education services for low income, women-headed families in the District of Columbia and Prince George's County. The study engaged directly with low-income women and child care experts, gathering insights into their needs, experiences, and challenges while identifying ways for the Foundation to strategically allocate resources to build community demand for accessible, high-quality childcare and early education. The study found that in D.C, 70% of families living in poverty were women-headed households, 1 in 3 children lived in poverty and the average annual cost of full-time center-based care for an infant was roughly \$22,000 or about 90% of the median income of a female-headed household.

In response to pivotal study, the Early Care and Education Funder's Collaborative emerged, uniting local investors in partnership with The Women's Foundation.
